Coronavirus Local Fiscal Recovery Fund (CLFRF) and American Rescue Plan Act (ARPA):

Mesarosh presented information to the board on the Coronavirus Local Fiscal Recovery Fund (CLFRF) and American Rescue Plan Act (ARPA). The Michigan Township Association is encouraging all townships to apply for the grant. Because the township has not submitted a grant application to the Federal government in the past, there are several applications that must be made before payment is made. Based on the 2019 population, the township is eligible for \$180,344.00. Specifications for funding requests are still being finalized. Mesarosh has submitted the application on time.
