emergency calls with no charge to Reading Township. REU has a mutual aid agreement with the Montgomery Fire Department. He also reported the Station 3 (located in Reading) is now manned 24/7 again. Ann Snellenberge Captain from Montgomery Fire Department spoke about what Montgomery Fire Department service offered to Reading Township. It was decided to have the attorney review any documents beforehand.
